TERMS AND CONDITIONS FOR – HOMEWARES GIVEAWAY COMPETITION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in 'IKEA Cross-shop' Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in Sydney local time (AEST). All monetary amounts are expressed in Australian dollars, unless otherwise stated.
